PURPOSE OF REQUEST				

To consider the proposal from the Town of Okotoks to partner on the construction of a performing arts facility within the future Okotoks high school campus.

#### BACKGROUND

A report on a proposed High School Campus Theatre project was presented at the May 27, 2025 Town of Okotoks / Foothills County Intermunicipal Committee meeting.

The following motion was made by the Intermunicipal Committee:

MOTION: By Councillor Siewert that consideration of the Theatre be forwarded to Foothills County Council regarding partnering on a new community theatre asset. Carried Unanimously

A statement of commitment between the Town of Okotoks and Foothills School Division is required to be executed by June 15, 2025.

If Foothills County is interested in partnering, then guidance is requested with regards to whether the new theatre would be governed by the municipalities' current cost sharing agreement or other cost sharing principles.

#### **REQUEST OF COUNCIL**

#### Proposed Motions:

#### Option #1 - Approval

That Council acknowledge the request from the Town of Okotoks to partner on a new community theatre asset and authorize the CAO to execute a shared services agreement with the Town of Okotoks.

#### Option #2 - Postponement

That Council acknowledge the request from the Town of Okotoks and postpone its decision on partnering on a new community theatre asset to allow administration to obtain additional information for consideration at a future meeting of Council.

#### Option #3 - Refusal

That Council acknowledge the proposal from the Town of Okotoks and deny the request to partner on a new community theatre asset.



## Motions of Okotoks Town Council

MOTION 25.C.113: That Council support the construction of a theatre at the new Wedderburn High School, with the addition of a loading dock, as recommended by members of the local arts and culture community, and budget amendments up to \$6.5M being brought forward for consideration by April 28, 2025.

MOTION 25.C.114: That approval be provided for the addition of a theatre at Wedderburn High School as an addition to the 2027 Capital Budget up to \$6.5M with funding sources of \$4.7M from Arts and Culture Reserve and \$1.8M from Reserves.





# Targeted Engagement

- Working with groups to understand their financial capacity to support the capital




### **Conceptual Floor Plan**

# **Benefits of Partnership**

- Synergies: parking lot, facility amenities, flex space
- Shared Utilities: site services, electrical
- Design Efficiencies: mobilization, building systems, monitoring services
- Long-term Maintenance: lifecycle management, sustained facility quality
- Alberta Infrastructure's estimated value of partnering = ~\$11M

# Project Next Steps

- 1. Town of Okotoks Council Approval of budget/scope
- 2. On-going weekly meetings between the Town of Okotoks and Alberta Infrastructure
- 3. Statement of commitment between Town of Okotoks and Foothills School Division required to be executed by June 15, 2025
- 4. Partnership agreement between Foothills School Division and Alberta Education required to be executed by August 15, 2025

If there is interest in partnering, then guidance should be provided if the new theatre would be governed by the municipalities' current cost sharing agreement or other cost sharing principles.
